Government of India has received a credit from the International Development Association (IDA) and a grant from the Department for International Development (DFID) in various currencies and intends to apply a part of the proceeds of this credit to eligible payments under the Contract for which this invitation for quotations is issued.

3. BID PRICE/Conditions

- a) The contract shall be for the total number of spots as described above. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
- b) All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- c) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d) The prices shall be quoted in Indian Rupees only.
- e) The bid shall remain valid for the financial year 2017-18. It can be extended for the further period only after the approval of RSACS.

4. Each bidder shall submit only one quotation.

5. VALIDITY OF QUOTATION

Quotation shall remain valid for a period of not less than 90 days after the deadline date specified for submission.

6. EVALUATION OF QUOTATIONS

The purchaser shall evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) are properly signed; and
- (b) confirm to the terms and conditions and specifications.

7. AWARD OF CONTRACT

The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

7.1 Notwithstanding the above, the purchaser reserves the right to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.

7.2 The bidder whose contract is accepted will be notified of the award of the contract by the purchaser prior to the expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

8. Payment shall be made on submission of bill after satisfactory work.
